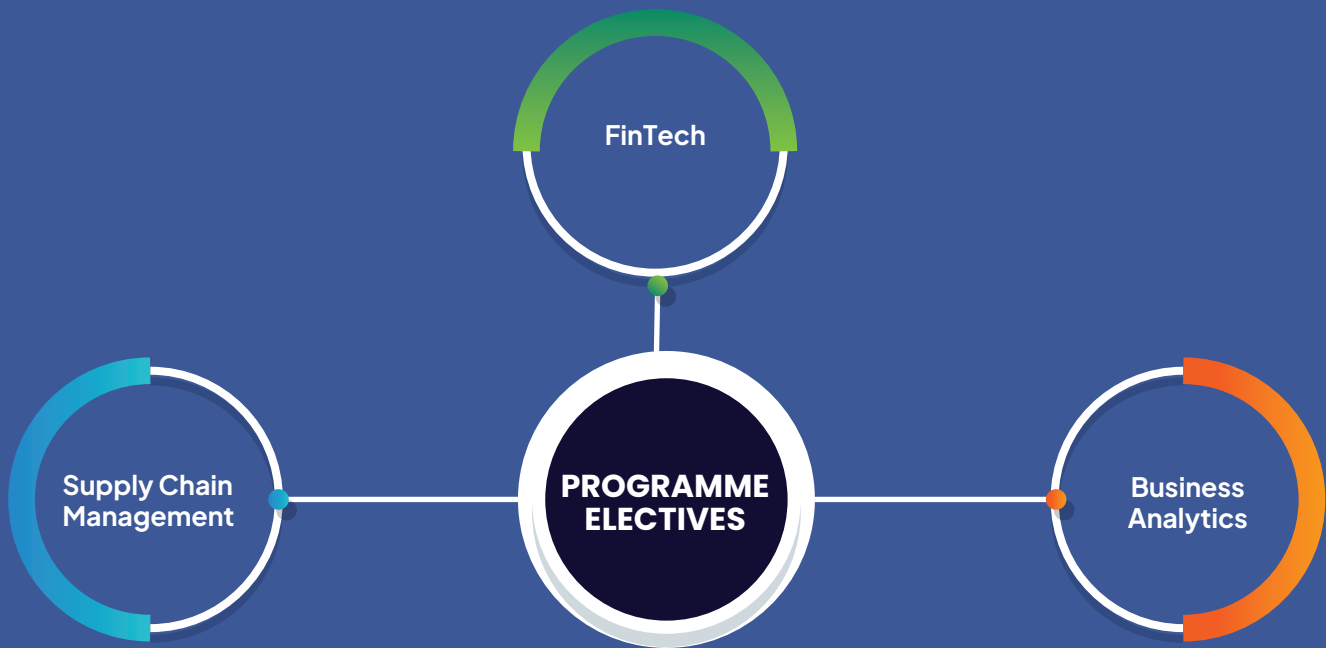

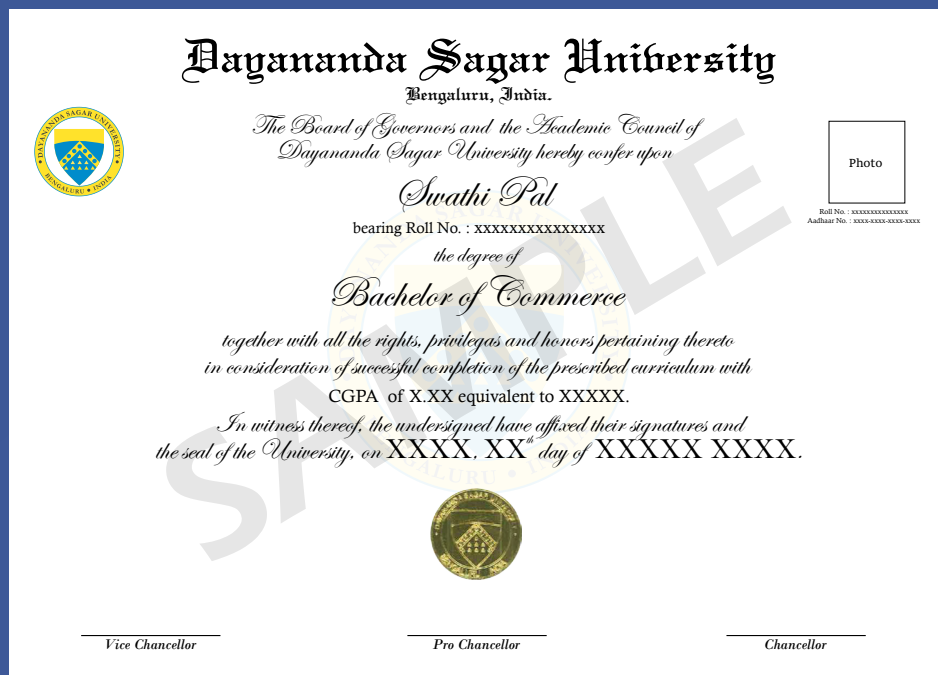
Admission Eligibility Criteria

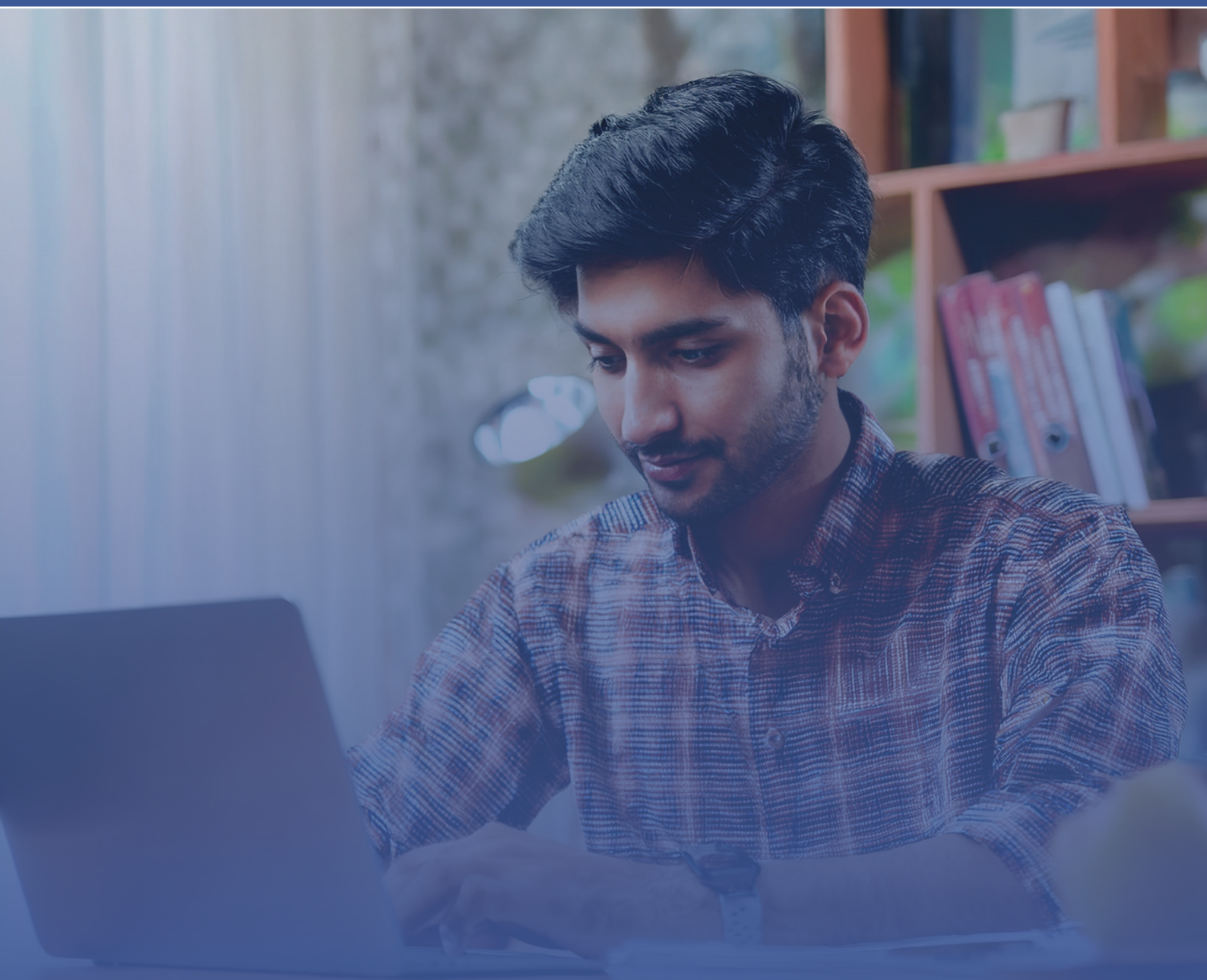
